Contract Agreement

THIS AGREEMENT made the [day] day of [month][year] between Project Director, Establishment of Novotheatre, Rangpur Project, Novotheatre, Ministry of Science and Technology, Bijoy Sarani, Tejgaon, Dhaka-1215, Bangladesh (hereinafter called "the Employer") of the one part and Robert Paul, Design Director, LCI Productions Limited, 55 Merthyr Terrace, London, SW13 8DL, UK (hereinafter called "the Contractor") of the other part: WHEREAS the Employer invited Tenders for certain plant and services, viz, Supply , Installation, Testing and Commissioning of Immersive Simulation Theatre on Turnkey basis for Establishment of Novotheatre, Rangpur Project and has accepted a Tender by the Contractor for the supply of those plant and services in the sum of USD 1,260,000.00 (USD One million two hundred sixty thousand Only) and BDT 200,000.00 (BDT Two hundred thousand Only) (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the General Conditions of Contract hereafter referred to.
2. The following documents forming the Contract shall be in the following order of precedence, namely :
 - (a) The signed Form of Contract Agreement;
 - (b) The Notification of Award
 - (c) The Tender and the appendices to the Tender
 - (d) Particular Conditions of Contract;
 - (e) General Conditions of Contract;
 - (f) Technical Specifications;
 - (g) Drawings;
 - (h) Price Schedules of Plant and Equipment and;
 - (i) Other document including correspondences listed in the PCC forming part of the Contract
3. In consideration of the payments to be made by the Employer to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Employer to provide the plants and related services and to remedy any defects therein in conformity in all respects with the provisions of the Contract.

4. The Employer hereby covenants to pay the Contractor in consideration of the provision of the plant and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.
5. Appendices listed in the attached List of Appendices shall be deemed to form an integral part of this Contract Agreement. Reference in the Contract to any Appendix shall mean the Appendices attached hereto, and the Contract shall be read and construed accordingly.
